Launch Point: Red Fox Park, adjacent to the Route 73 Bridge over the Perkiomen Creek at Schwenksville

Parking: At the PWC headquarters across Route 73 from Red Fox Park

Take Out: Hoy Park along Arcola Road in Lower Providence Township. A picnic lunch will be provided at the end of the trip.

Total Distance: About 7 miles.

Items to bring with you: Water Bottle and snack. A change of dry clothes can be transported for you to the take out point.

Returning to the PWC: Limited transportation from Hoy Park back to the PWC Headquarters will be available after the Sojourn. If you are sojourning with a friend, you may want to leave one car at Hoy Park before you arrive at Red Fox Park for the launch.
