The Perkiomen Watershed Conservancy is your community resource for protecting our local waterways, especially from the ubiquitous problem of stormwater pollution. In addition to our award-winning environmental conservation and restoration projects, environmental education classes, and our numerous community events, the Conservancy assists its member municipalities in meeting the requirements of the Municipal Separate Stormwater System (MS4) permit.

Many of you have chosen to take advantage of this annual program, but others are missing out on a great opportunity to gain stormwater literature, workshops, staff training, stormwater reduction statistics and grant funding designed specifically to help you meet your MS4 permit requirements. Our member municipalities also receive a comprehensive list of the benefits they received from the Conservancy's MS4 program to utilize in their year-end reports. To take advantage of these great benefits, all you have to do is partner with the Conservancy!

We invite your municipality to join the Perkiomen Watershed Conservancy as a member for the 2024 MS4 permit year (Year 22). **Remember, even if you are a current member, you will need to renew your membership for the 2024 permit year.** Our municipal membership levels and corresponding benefits are listed in the table on the enclosed Membership Form. Note that at the Patron and Benefactor levels, you will receive all of the benefits of the lower level(s) as well.

## 2024 Membership Offerings

Listed below are the program offerings for 2024 permit year based on membership levels. Please note that at the Patron and Benefactor levels, you will receive all the benefits of the lower level(s) as well:

**Benefactor Level:** \$1000 – Benefactors are eligible for the following membership benefits:

- 1. *Municipal MS4 Grant Program*. You will have the opportunity to submit a grant application to install a stormwater BMP within your municipality. The grant will be submitted to PWC who will review the applications and carry out the selected project. Municipalities that choose the benefactor level will be sent the grant application and more information about the program separately.
- 2. Rain Barrel Workshop. Your residents will be able to participate in a Rain Barrel Workshop where a PWC staff member will demonstrate how to build and install rain barrels on residential properties. PWC will provide all the necessary equipment and materials for attendees to follow along and build their own rain barrel. Residents must pay a registration fee in order to attend. Municipalities will be responsible for scheduling workshops.
- **3.** *Municipal Staff Workshop*. You will have the opportunity to receive one PWC provided training session for municipal staff. The session will take place at a municipal facility of your choice and will cover topics like good housekeeping for municipal operations and illicit discharge detection and elimination. Municipalities will be responsible for scheduling workshops.

**4.** Stormwater Reduction Statistics Package. This informational package will show which PWC events your municipality and/or residents participated in and will provide you with statistics from those events to be used in your MS4 reports. Statistics could include the number of volunteers involved/volunteer hours, amount of trash removed from a site within your municipality, number of trees planted along riparian areas, amount of invasive species removed from waterways, etc.

**Patron Level:** \$500 – Patrons are eligible for the following membership benefits:

1. Stormwater Reduction Statistics Package. This informational package will show which PWC events your municipality and./or residents participated in and will provide you with statistics from those events to be used in your MS4 reports.

**Promoter Level: \$250** – Promoters are eligible for the following membership benefits:

**1.** *Educational Articles.* You will be given access to educational articles, pamphlets or handouts created specifically by PWC to educate residents about stormwater pollution issues. Materials will be provided electronically; municipalities will be responsible for distributing the materials.



#### **Your Community Resource for Stormwater Projects**

The Conservancy is always on the lookout for new and exciting projects! Not only do we partner with local municipalities through our MS4 grant program, we also offer project support and assistance for other grant programs and stormwater projects. We help cut project costs by working with your existing public works staff and community volunteers to install DEP approved stormwater BMPs. Below are some examples of projects that the Conservancy has partnered with municipalities to complete:

- Rain gardens in 2022 2023, the Conservancy installed a 2 rain gardens at the following locations: Stony Creek Park in Lansdale and Lenape Park in Skippack.
- **Riparian Tree Plantings:** in 2023, the Conservancy planted a total of 455 trees along local waterways within 7 different municipalities.
- Aqua-blocks Installations modular underground tank system that can be installed underneath rain gardens or bioswales to increase the garden's stormwater infiltration capacity. Last fall, the Conservancy installed aqua-blocks as part of the rain garden project in Stony Creek Park.
- **Stormwater Basin Naturalizations** in the fall of 2021, the Conservancy installed native perennials and shrubs as part of a stormwater basin naturalization project located in Douglass Township.
- Streambank Restorations in 2021 2022, the Conservancy partnered with Lower Salford Township to restore streambank habitat along the Skippack Creek. This included re-grading the streambank and planting 10,000 native perennials, 125 trees, and 2,000 live stakes. Through their partnership with the Conservancy, Lower Salford was able to save over \$300,000 in project costs. In 2023, the Conservancy received the Governor's Award for Environmental Excellence for the Reiff Park project.
